## **Recall Description:**

- Problem / Issue:
- Due to a misunderstanding in the final disposition of a wafer lot, 471 parts with duplicate IDs were shipped to customers; the affected wafer lot is HJ0051100A, the affected assembly lots 384211 & 384221, date-code 2146 (marked on the parts and on the reel labels).
- Note that the lot numbers on the labels could be sublots, of the format 384211.xx or 384221.xx.
- The duplicate ID has an impact if:
  - o it is used to identify a gateway in a network AND
  - $\circ$  both gateways with the same duplicate ID are used in the same network.
- If the duplicate ID has an impact:
  - If you have unused/unmounted parts from the above 2 lots: please return to the addressed listed below for replacement.
