## **Maximum Peak Pulse Power Rating**




### **Peak Pulse Power and Current Derating**







### **Steady State Power Dissipation Derating**





# **Typical Junction Capacitance**



components. We recommend a manual inspection after potting to avoid these effects.


### **Storage Conditions**
