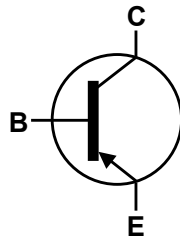

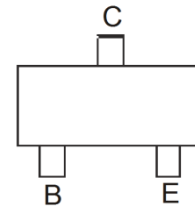

Device Symbol



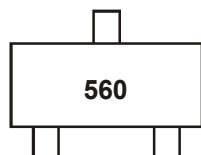
Top View

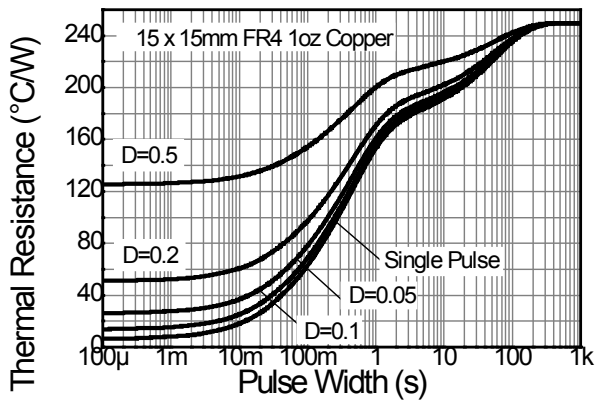

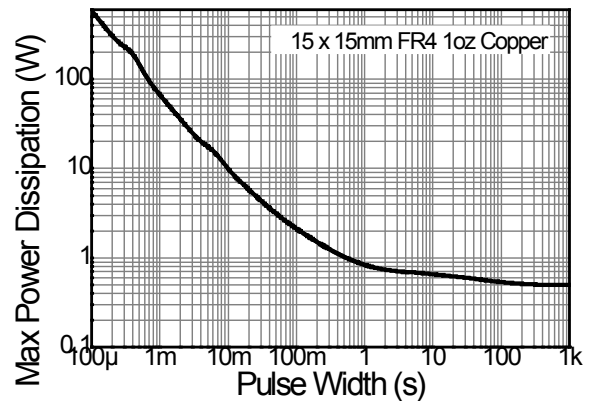
Safe Operating Area

Transient Thermal Impedance



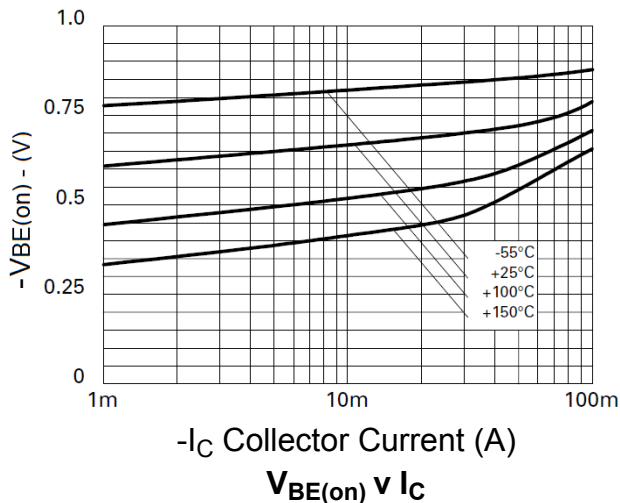
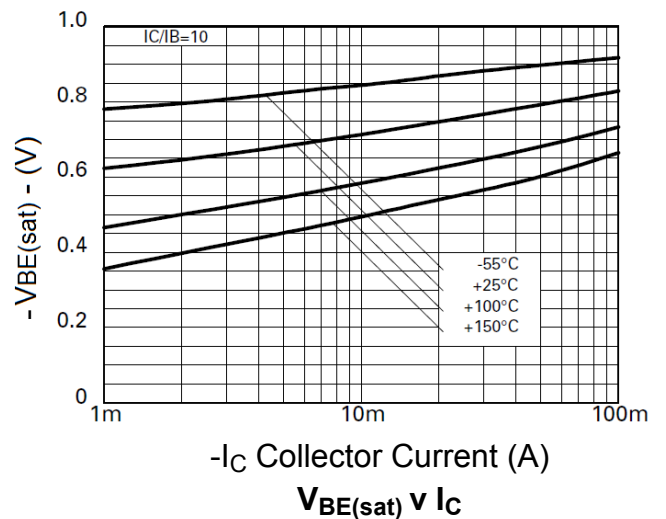
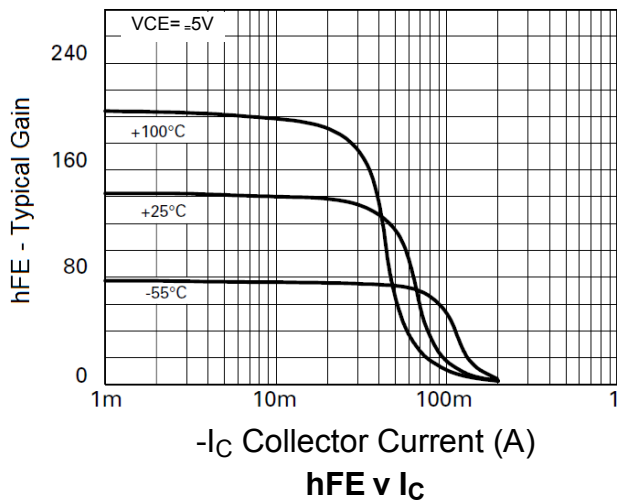
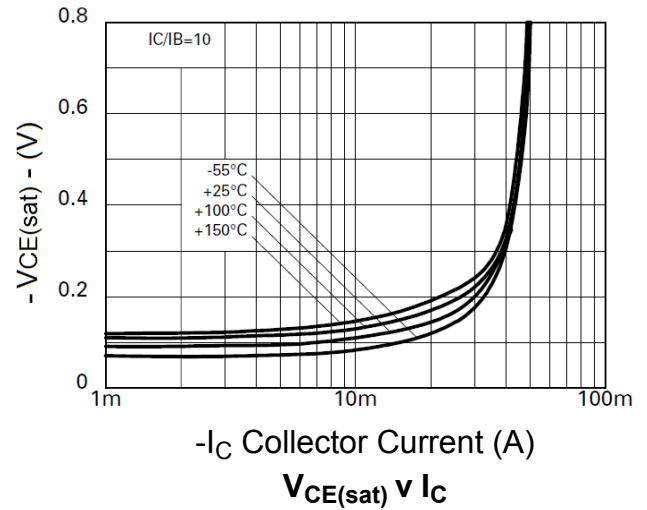
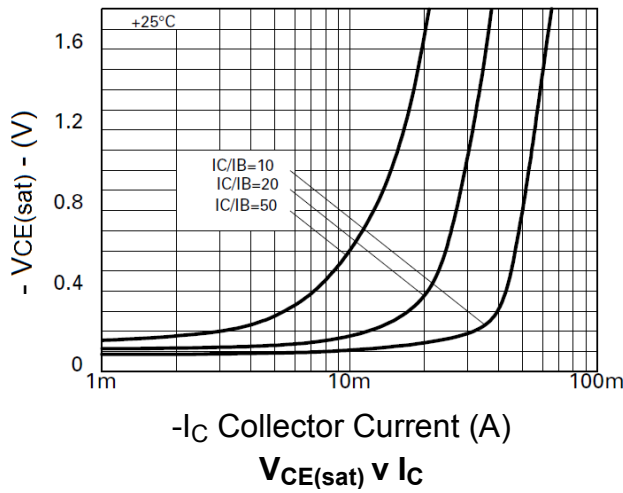

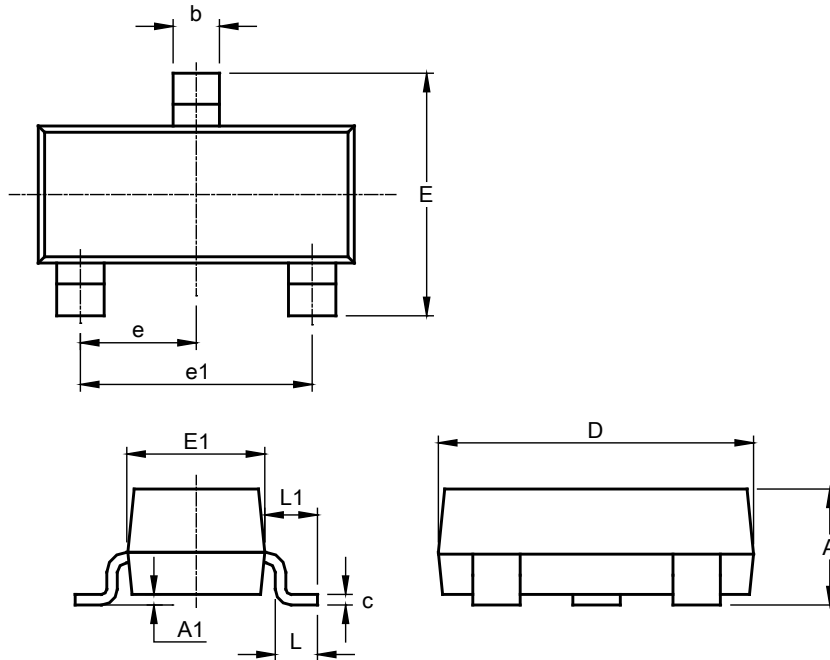
